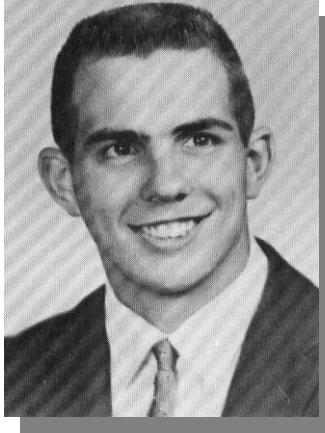
**2012 COMMENTS:**

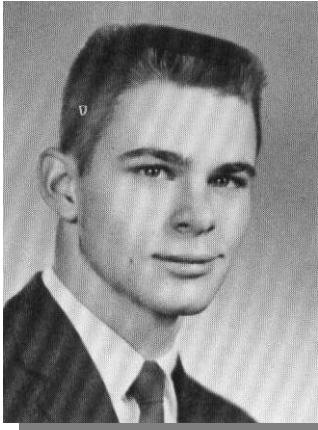
In addition to a large circle of friends, Chuck is survived by his wife, his children, grandchildren and sisters. He was predeceased by his parents.

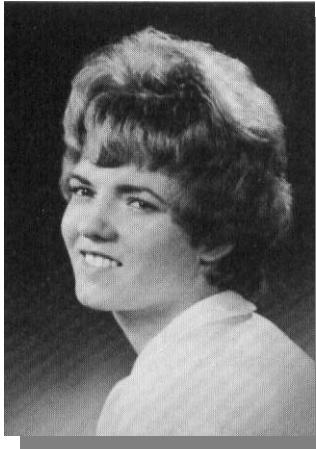

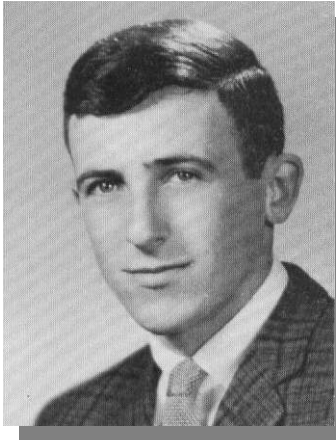

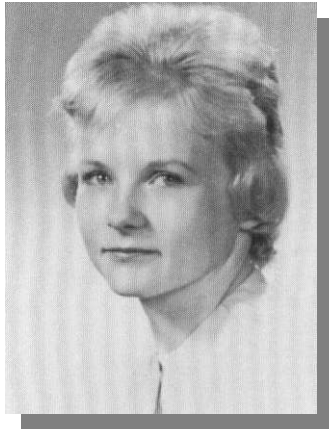

First, let me say that I am sorry that I am unable to make this 40th reunion. I would much prefer to share my last 40 years with you personally but because of prior commitments, this is not possible.

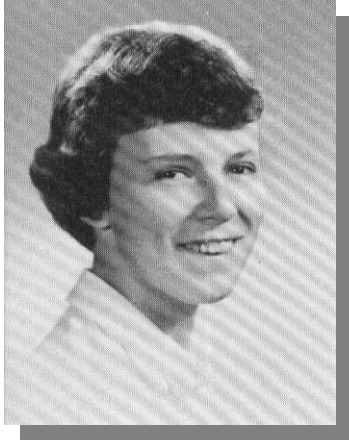
So let me start with where I am now. I am retired with my husband and living in The Villages in Lady Lake, FL. I play lots of golf and still have my love for painting.

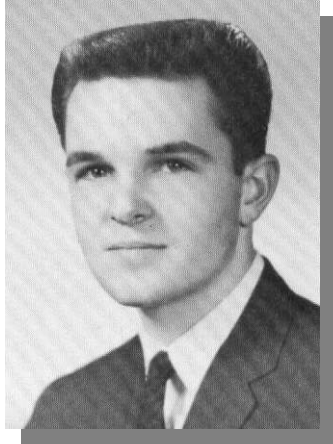

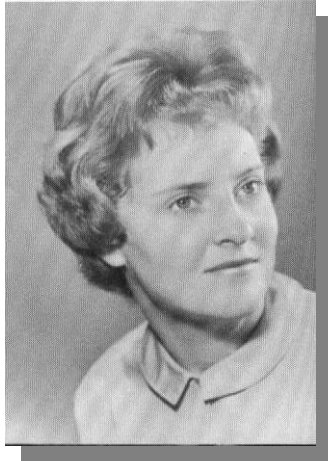
